MINUTES

A meeting of IQAC was convened on 16 April 2019 at 3.00 pm in Executive Hall of Madhav Bhavan. The Meeting was chaired by Hon. Vice Chancellor and was attended by Registrar, Deans, HoDs and Officers of the University.

The meeting was initiated with welcome remark by Hon. Vice Chancellor. The Director IQAC, Prof Pramod K Verma, presented an overview of preparations of NAAC activities. He further presented certain crucial aspects and doable actions by the University which may enormously enrich the quality of teaching-learning and best practices at the University. Prof M. S. Parihar, presented the current status of World Bank Project and RUSA assistance to the University. He informed that Rs. 50.00 crores has been sanctioned by the World Bank and Rs. 20.00 crores by RUSA for various proposals submitted by the University.

Some of the important and urgent actions to be undertaken on priority were identified as follows:

1. University Website:

- a) Regular and scheduled updating of University website
- b) Creation of University E-mail system at Government Portal viz. ac.in, gov.in, nic.in
- c) Uploading of University Magazine and University Journals on University Website.
- d) Creation of a new drop-down menu, "What is New......", at University Website.
- e) Any other addition, modification, deletion, as and when needed.

2. University Communication Groups:

University may create various and targeted communication groups for faster and manageable communication. Some of the identified groups may be as follows:

- a) University Officers
- b) University Deans
- c) University Deans + Faculty Members
- d) All employees of the University
- e) Principals of affiliated colleges
- f) Respected citizens of University jurisdiction
- g) Alumni of the University
- h) Any other, as and when required

3. F.A.Qs. (Frequently Asked Questions)

The University has wide geographical jurisdiction. An online display of systematic and classified FAQs over various common queries would enormously reduce such visitors as students/parents coming to the University for enquiry or other similar work; many of

them are from rural and economically challenged background. Some of the classified FAQs may be as follows:

- a) Admissions
- b) Examinations
- c) Results and Degrees
- d) M.Phil./Ph.D./Post-Docs
- e) Alumni
- f) Donations to the University
- g) Any other, as and when required

4. University Social Responsibility

University may take up several programs at various levels for the benefit of the society. Some of them may be listed as follows:

a) Identification and solution of Local Issues related to education, health, farming, energy, traffic, social security etc.

 b) Pro-active participation in National Missions related to education, health, farming, energy, transportation, smart city, women empowerment, social and gender equity programs etc.

c) Pro-active leadership in programs like plantation, water conservation, organic farming, smart farming, waste to wealth programs, promotion and patronization of local industries etc.

d) Leadership in identification, conservation and promotion of local/regional knowledge, wisdom, traditions, culture and technology.

5. Research and Innovation Promotion

University is expected to promote innovators and innovations. Following actions may be taken on priority:

 a) Development of collaborations and entering in MOU with identified reputed institutions.

 b) Develop collaboration with National Innovation Council/National Innovation Foundation.

c) Develop collaboration with National Research Development Council

d) Initiate competitions and awards for innovative ideas, development of prototypes/models etc.

 e) Initiation of joint ventures with local industries, local artisans etc. for innovation promotion and IPR generation programs.

6. Smart Infrastructure

University must convert itself towards energy efficient, eco friendly, smart infrastructures. Some suggested measures may be listed as follows:

- a) Development of parking facility near the entrance and providing support for erickshaw/or bicycle for internal movement.
- b) Making 'Barrier free access' to University buildings
- c) Making smart and efficient waste disposal system

- d) Developing rain water and roof water harvesting structures
- e) Enhancing campus vegetation index
- f) Deploying solar power generation units
- g) Construction of Convention Hall/Auditorium with attached Committee rooms
- h) Development of sports infrastructures and facilities

7. A 360 degree personality development approach

Adoption of Choice Based Credit System (CBCS) by University is certainly a welcome step. However, a major component of personality includes communication skill and hobby nourishing. Any all round personality development effort and program must incorporate these aspects too. Given the time constraint of University leaching-learning-examination system, these may be addressed at additional hours and even without credit, for interested learners. These efforts may include Communication Skill, Yoga and Meditation, Sports, Music, Dance, Singing, Exposure to social services etc.

8. Visionary Approach

The University is an institution that provides leadership to nation and society. The University has to keep pace with evolving knowledge and technology including changing governmental-industrial-societal scenario and demands. Accordingly it has to clearly identify its path along with visible milestones. It needs to identify its goals and make distinctive and effective implementation plans for short term, midterm and long term. The Mission and Vision of University including Achievement Plan must be well defined.

The meeting ended with final remarks of Hon. Vice Chancellor.

Minutes of the Meeting of Deans and Heads of Departments

Date: 13-01-2021; Time: 4.00 pm; Venue: Executive Committee Meeting Hall

Chair: Prof A K Pandey, Hon. Kulpati Ji

The meeting started with Hon Kulpati ji at Chair. The Registrar, Dr D K Bagga welcomed Hon Kulpati ji and all members. The Director IQAC, Prof Praamod K Verma presented the aim, scope and expected outcome of meeting. The list of Members who attended the meeting is appended.

1. Agenda: Adoption of MOOCs/Swayam courses ill University curriculum. The Ministry of Education, Govt. of India including UGC, AICTE, etc. are offering several online learning materials and course programs for students. These programs can be taken by the students as an alternative to normal programs at their curriculum. The marks/credits earned by the students in these MOOCs/Swayam courses can be directly taken for their result computation.

Resolution: The need, possibility and action plan to implement MOOCs/SWAYAM courses in University curriculum were discussed in detail. UGC has directed to include 20-40% of such courses in the regular curriculum of University. Prof Alka Vyas was nominated as coordinator for this action and was given responsibility to carve an action plan in consultation with Director IQAC such that it may be implemented from next academic session 2021-22.

Agenda: Implementation of National Education Policy 2020 at University
Government of Madhya Pradesh, Department of Higher Education has adopted the
National Education Policy 2020. Accordingly, University has to reorient itself according
to NEP 2020.

Resolution: The National Education Policy 2020 is to be implemented from academic session 2021-2022. Dr S K Mishra was nominated coordinator for implementation of NEP 2020 at University. He was given responsibility to suggest a task force at University level to phase out the action plan on time line keeping University SWOC in the centre.

3. Agenda: Internet and Networking Facility in the University

Looking into the growing IT applications in University including online classes, meetings and other activities, the University is taking action to provide high speed internet and networking facility to its departments and administrative offices.

Resolution: It was unanimously decided that each university department and supporting centers (viz. library, sports, hospital, various Chairs etc) must be given internet and networking facility through optical fiber line. It was decided to implement this resolution on priority basis. Dr Umesh Singh and Dr D D Bedia were nominated as coordinators for this action.

4. Agenda: List of subject wise online free journals/magazines

With growing information technology applications in University system, it is necessary to provide digital version of resource and reference materials to the students, researchers and teachers. It is expected that each department will provide online resource materials/journals/magazines to the interested users. At the outset, each department is expected to enlist such subject wise online materials which are freely available for distribution.

Resolution: In order to foster better teaching, research and innovation eco-system in the University it was decided to provide digital and online access to research magazines, research journals and other related resource materials to the teachers, researchers and students. At the outset, it was decided to enlist subject wise list with their web links to be uploaded on university portal. Dr Sonal Singh was nominated as coordinator for this action.

5. Agenda: Adoption of Government of India/Government of Madhya Pradesh citizen centric schemes at University

The University is adopting various programs notified by Central/State Government. It is expected that each department should also take action at its own level to conduct such programs. Some of the programs to be adopted are

- Swachh Bharat Abhiyan
- Aatmnirvar Bharaat Abhiyaan

Resolution: The matter of citizen centric schemes and University Social Responsibility was discussed in detail and it was resolved to implement them in the University. The
