**THREE YEARS LAW COURSE**  
(Semester System)

REVISED

**THE DEGREE OF BACHELOR OF LAW (LL.B.)**

1. The Course of LL.B. shall be of **Three Years duration**. All the colleges shall be whole time (day) colleges.
2. The Ordinance will be applicable to all the University teaching, departments, affiliated government and private colleges under its jurisdiction.
3. **Admission: - Admission for 3YDC. Law Course:**

An applicant, who has successfully completed Graduation degree course or equivalent degree from constituted institute or from the University recognized by UGC, may apply for admission into the course.

Provided that applicants who have obtained degree Certificate or equivalent certificate after prosecuting studies in distance or correspondence method shall also be considered as eligible for admission in Three year law course .

**Explanation:** The applicants who have obtained degree through Open University system directly without having any basic qualification for prosecuting such studies are not eligible for admission in the law courses.

**PROHIBITION TO REGISTER IN OTHER COURSES** - The candidates admitted to the Course, shall not be allowed to pursue any other course except certificate course in any Indian or Foreign language or computer application being conducted by this University on part-time basis in the evening or through Distance Learning with prior permission of the Dean / HOD, Faculty of Law otherwise his candidature for LL.B. 3 Year Law Course will be cancelled forthwith.


**4. MINIMUM MARKS IN QUALIFYING EXAMINATION FOR ADMISSION**

Graduation with **45% aggregate marks (40% aggregate marks for SC, ST and 42% aggregate marks for OBC candidates)** as per BCI Norms.

Provided that such a minimum qualifying marks shall not automatically entitle a person to get admission in the university, but shall only entitle the person concerned to fulfill other criteria notified by the university, from time to time, for admission.

- (i) "Candidates seeking admission to the LL.B. degree course must have pass graduation degree course from this University or any recognized university as per UGC Norms & must have secured minimum percentage of marks specified under the Admission rules notified by BCI, Higher Education Govt. of Madhya Pradesh from time to time.
- (ii) The Candidates for the LL.B. Degree will be required to pass **SIX SEMESTER** examinations, which will be held in the month of **November -December** and **May- June** of each academic year.
- (iii) A Candidate who, after taking to Bachelor's degree of this University or of any other University recognized for this purpose, has completed a regular course of study of law in a constituent or an affiliated College of this University for an academic semester shall be eligible for appearing in that aforesaid examination.
- (iv) A Candidate who passed LL.B. First Year or Second Year Examination from other University, which has introduced either Semester pattern or Annual Examination pattern or Three Year Degree Course in Law after 3 years graduation will not be admitted to III semester (II year) or V semester (III year) of LL.B. course unless he has passed the I & II both Semesters. (I year) or III & IV both semesters (II year) Examination from the University concerned and  
Provided further that the course is of equivalent standard with almost identical syllabus as is required for the respective examination of this University.

Provided that if a candidate who passed the LL.B. First year ( I & II Semester both) or Second year (III & IV Semester both) Examination from some other University, desire to appear at the LL.B. Second or Final Year Examination of this University i.e. III or IV Semester respectively of this University, **he will be required to appear, along with the papers prescribed for the LL.B. Second year (III & IV Semester) or Third year (V & VI Semester) in such papers of the previous year's examination of this**



University as did not from the part of the curriculum for LL.B. First year or LLB Second year Examination of the University from which he passed the said examinations.

Provided further that a candidate who has passed from other University in one or more subjects but not in all the subjects included in papers for the LL.B. First or Second Year scheme of Examination of this University would not be exempted from appearing at the said paper of the LL.B. First or Second Year of this University while appearing at the LL.B. Second or Final Examination under above rule;

## 5. ATTENDANCE PROVISION FOR END TERM SEMESTER EXAMINATION

1. The Students shall be required to put in a minimum attendance of 75 % of the lectures on each of the subjects as also at tutorials, moot courts and practical training course.

Provided that in exceptional cases for reasons to be recorded and communicated to the Bar Council of India, The Dean of the faculty of Law and the Principal of Law Colleges may condone attendance short of those required by the Rule, if the students had attended 60 % of the lectures in the aggregate for the semester or examination as the case may be.

**Provided that if the percentage of attendance is deficient on account of:-**

**To prevent from the Participation to appear in**

- (i) University Examination
- (ii) Inter-University, University or Inter-Collegiate Sports tournaments/Youth Festivals /University Level Debates/ Cultural Activities, National and International Tournaments, without the previous sanction of the Dean/HOD of Faculty of Law.
- (iii) Voluntary donation of blood certified by a Government Doctor of Gazetted rank or University medical officer.
- (iv) Attendance and/or participation in International/National / State Moot Court competitions/Debate competitions;
- (v) Attendance at the extension lecture (s) organized by the Faculty of Law.

## 6. FORMAL DRESS CODE DURING CLASS HOURS & INTERNSHIP

Formal Dress Code shall be applicable during the normal class hours, during internship and in moot court exercise as follows:

**For Boys:** White shirt, long black trousers, Black tie with mentioning "F O L" on top of it, Black buttoned up coat, White socks, Black shoes.

**For Girls:** White shirt, long black trousers or White Punjabi dress of Churidar Pajama or Salwar and Kurta with dupatta (white or black), Black tie with mentioning "F O L" on top of it, Black buttoned up coat, White socks, Black shoes.

## 7. Examination Rules & Rules for promotion to the next higher class (Semesters)

- (i) **Academic Year:** means Two consecutive (one odd + one even) semesters constitute one academic year.
- (ii) The examinations will be held **odd to odd and even to even semester pattern** only.
- (iii) If a candidate has cleared all papers and **aggregate 45%** covered than result will be **pass**.
- (iv) If a candidate cleared in all papers but unable to make **aggregate 45%** then result - 'ATKT In Aggregate'.
- (v) If a candidate has covered **aggregate 45%** but failed in **1 or 2** subject, then result will be **ATKT**.
- (vi) If a candidate has covered **45%** aggregate but failed in **more than 2 papers** then result will be **Fail**.
- (vii) If a candidate has got **less than 45%** aggregate and failed in all papers than result will be **fail**.
- (viii) If candidate carries **backlog in 4 subjects** than he is promoted to next semester.

- (ix) If a student declare ATKT in (III & IV) Semester. He will become eligible for admission to V Semester (III Year) course with backlog of one or two papers of his choice at the next available identical semester, so that he gets an opportunity to secure 45% Marks in aggregate of III & IV Semester.

Provided that if result of student shall be declared as 'ATKT' or Fail again in any of semester Examination i.e. I, II,III,IV or V semester Examination then result of VI semester will be withhold (W.H.) till Passing out the previous semesters. Only his marks of internal assessment from his previous attempt in II and IV Semester Examination will be carried forward.

- (x) If such student does not avail of this opportunity of ATKT or does not secure 45% marks in aggregate in identical I, II Semester III, IV Semester or V, Semester of that identical Year of Examination, he will become an ex-student of that college & he shall have to appear in all paper.

Candidates shall be examined according to the scheme of examination and syllabus as approved by the Academic Council from time to time.

- (i) To pass each semester examination, a candidate must obtain at least 40% marks in each written paper, practical work /Viva-Voce and 45% marks in aggregate.
- (ii) Each written paper for the respective semester examination shall be set and evaluation of the answer books shall be done as per the University rules.
- (iii) The Internal Assessment marks regarding examination will comprise of 70 Marks Theoretical and 30 marks (70 + 30) for practical exam of LL.B I Year & LL.B. II Year.
- (iv) LL.B. III Yr. Moot Court Internal Assessment exam will be conduct as per BCI Norms Marks distribution scheme are as follows :-

The Internal assessment of II, and IV Semester Examination will be made out of 70 (Seventy) marks in theory Papers and Internal Evaluation of 30 (Thirty) marks shall be made by the subject teacher, teaching the paper in accordance with the following rules:

#### INTERNAL EVALUATION: MID-TERM EXAMINATION

- a) The schedule of Mid-Term tests shall be notified to the students by the institute as per schedule of University semester examination.
- b) Questions papers for mid-term tests shall be set by the internal examiner from the 50% of the syllabus of the course. The answer books will be assessed by the teacher concerned. The assessed answer books will be shown to the students and grievances, if any will be handled by the teacher.
- The marks of the mid-term tests will be forwarded to the Controller of Examinations by the Head of the Department through the Principal / Dean of the Faculty of Law.
- c) No remedial Mid-Term Tests would be conducted.

Criteria for Awarding Semester Attendance Marks will be as prescribed by the University as follows:		
a.	Attendance above 95%	10 Marks
b.	Attendance between 91% to 95%	9 Marks
c.	Attendance between 86% to 90%	8 Marks
d.	Attendance between 81% to 85%	7 Marks
e.	Attendance between 75% to 80%	6 Marks
f.	Attendance between 65% to 74%	5 Marks

**Assignments:** - Allotment of subject topic by the Institute/College or UTD to each student and student shall have to present written Assignment to the Institute/ college or UTD for internal assessment as per prescribed format of assignment.

**Viva – Voc –**

- (i) It shall be conduct by the institute in association with external examiner as per Notification issued by the University.
- (ii) **External Examiner:** shall mean an examiner who is in employment of the University jurisdiction and nominated by the University for Viva – Voc Examination for each institute.
- (iii) If any student is absent in **Viva-Voc Examination on Medical ground i.e. Ill ness or undergone medical treatment in Operation Theater**, then on application & Medical certificate submitted to the University by the candidate , an universal viva-voc exam of all colleges' can be conduct by the university as per the notification issued regarding date, time & place of viva-voc examination.
- (iv) All Practical examinations are compulsory for all the students & **45% marks** must be required to obtain in all practical examination.
- (v) The Dean/HOD will preserve the records of the sessional/practical work up to **six months** from the date of the declaration of the result of concerned semester examination.

8. Revaluation of answer books is allowed as per provision of Ordinance
9. The subjects and papers for each year of LL.B. shall be prescribed by the Faculty of Law on the recommendations of the Board as Studies, unless provided each paper will carry **100 marks** and will be of **3 hours duration**.
10. If not provided otherwise the candidate will have to pass separately in written papers and practical, if any prescribed.
11. The minimum passing marks in each semester's examination shall be **45% in the aggregate** of all the papers and **40 marks** in each individual paper. Division to successful candidates for the LL.B. degree will be assigned at the end of Final Year Examination on the basis of the **aggregate of the total marks obtained** by him at the LL.B. First Year Second Year and Final Year Examination i.e. all **Six Semesters** as under:

**First Division : 60 % or above**

**Second Division: 48% or more but less than 60%**

- Note:**
- (i) No third division shall be awarded.
  - (ii) Candidates who obtain **75 percent** or more marks in the aggregate shall be declared to have passed the LL.B. degree course in the First Division **with distinction**.
  - (iii) V.C. Grace Marks as per rules can be awarded.
  - (iv) In each semester 1 grace mark may be awarded if a student has secured 45% in aggregate and is short of 1 mark in the minimum passing marks for a paper.
  - (v) A student has to be enrolled in the University as per University rules.
  - (vi) The examination should be palmed in such a way that the total period for any examination including the declaration of result is such that the next semester course starts in time.
12. For each paper there shall be lecture classes for at least **3 hours per week**
  13. Candidates appearing for the LL.B. Examinations shall have the option of answering questions through the medium of **Hindi** (Devnagri Script) or **English**.
  14. These rules are subject to change in accordance with the directives of Bar Council of India and instructions issued by Department of Higher Education, Govt. of M.P. from time to time and adopted and notified by the University.

**15 Disputes ;**

Any dispute arising out of this Ordinance or otherwise shall be decided by the Executive Council of the University, whose decision shall be final.

**Scheme of Examination :**

There shall be 25 university examination papers and three internal assessments, i.e., 28 papers in all, in the Three Year LL.B. Course spread over SIX Semester examination as per detailed examination scheme given below. Each paper shall be of 100 marks. Minimum passing marks in each paper are 36% The rules for passing in semester examination are given in the text of the Ordinance.
